Environmental Management is one of the priorities of Bventura Suzhou, as a key factor for its sustainable development, competitiveness, and adaptation to the social environment. In this regard, B Ventura has analyzed its internal and external context and is making a significant effort to align its management and facilities with the expectations of its stakeholders and current environmental regulations and legislation.

B Ventura's Environmental Policy includes a commitment to environmental protection, including pollution prevention and other specific commitments relevant to the organization's context, as well as a commitment to comply with legal and other stakeholder requirements and to continuously improve the EMS to enhance environmental performance.

B Ventura's Environmental Policy has been established as a framework for setting and reviewing environmental objectives and targets.

1. **Legal and Regulatory Compliance:** Compliance with current legislation at all times, and with all applicable regulatory requirements issued by government authorities (including international, national, regional, provincial, and local authorities) legally binding, as well as all those requirements subscribed by the company, with the commitment to communicate them to all B Ventura personnel and suppliers who, in their actions with the company, are involved in certain compliance with applicable requirements.
2. **Use of Sustainable Technologies:** The application of the best available economically viable technologies in its facilities, enabling more efficient use of natural resources and advancing towards a more sustainable energy model.
3. **Training and Awareness:** Training, educating, and raising awareness of all company personnel on the environmental aspects required by their work and our organization. Specifically, raising awareness about the importance of taking measures for environmental compliance.
4. **Setting Environmental Objectives:** Establishing Environmental objectives that enable continuous improvement in this area, provided with the appropriate financial and operational resources. Monitoring objectives and developing preventive and corrective actions as required by circumstances. Ensuring the achievement of set objectives, compliance with legal requirements, and the aforementioned principles through periodic internal and external audits of its Environmental Management System.
5. **Collaboration with Suppliers:** Promoting among the company's suppliers the adoption of principles similar to those outlined above, collaborating with them for their implementation and informing them of the applicable requirements.
6. **Greenhouse Gas (GHG) Emissions:** B Ventura is committed to reducing greenhouse gas emissions through the implementation of efficient operational practices, investment in low-emission technologies, and continuous monitoring of our emissions. This includes assessing our emissions and adopting clear and measurable targets for GHG reduction.
7. **Renewable Energy:** B Ventura will promote and use renewable energy sources whenever possible. We are committed to increasing the use of clean energy and investigating new technologies that allow sustainable energy generation. This is part of our ongoing effort to reduce our dependence on fossil fuels and minimize our environmental impact.
8. **Waste Reduction:** B Ventura strives to minimize waste generation in all our operations. We implement reduction, reuse, and recycling policies and actively work to reduce waste sent to landfills. Additionally, we collaborate with our suppliers and customers to promote sustainable waste management practices throughout the entire supply chain.
